Sharayh gave the board and update on projects they were working on and what would be coming up. She also inquired about the FY 2020 budget. Lemhi County Landfill Supervisor Scott Duncan told the board they were working on the cell expansion at the landfill. The new transfer truck should be ready soon. IN THE MATTER OF AIR METHODS AND LEMHI COUNTY AIRPORT BOARD

Jim Crawford, Fred McDonald Lemhi County Airport Board Members presented an application from Robert Schick for proposed board member. Ken Miner made motion and Brett Barsalou seconded to appointment him to the board. All were in favor.

Mike Jenkins with Air Methods presented the Operations Agreement to the board asking for approval to operate from the Lemhi County Airport. Brett Barsalou made motion to except operation agreement contingent to County Attorney Withers and written verification from the counties engineer, that the proposed use is consistent with the Airport Master Plan and Ken Miner seconded. All were in favor. The board ask Mike what their plans were. He stated they would like to be in operations by July 29, 2019. There goal is to cut down on flight time to get a critical patient to higher level of care. With them being stations here in Lemhi County they could save at least 45 minutes flight time getting another air ambulance to Salmon. They have hired 4 pilot, 3.5 nurses and 3.5 paramedics. They have housing here in Salmon and will be renting office space at Lenny's Airmotive. They are looking forward to serving Lemhi County.

Ken Miner made motion and Brett Barsalou seconded to go into executive session pursuant to Idaho Code 74-206(d) to hear indigent matters. Roll call vote was held.
